Hospital Authority Welcomes New Chairman

The Hospital Authority (HA) welcomes the appointment of Mr Wu Ting-yuk, Anthony as the new Chairman of the Authority, which was announced by the Hong Kong Special Administrative Region (HKSAR) Government earlier today (Tuesday, 12 October).

The Chief Executive of the HA, Dr William Ho, on behalf of the staff members, welcomes the appointment by the Chief Executive of the HKSAR of Mr Wu Ting-yuk, Anthony as Chairman of the HA. Mr Wu is a senior HA Member who is also the Chairman of Finance Committee and HA's Main Tender Board. He has once served as a member of the Hospital Governing Committee of Pamela Youde Nethersole Eastern Hospital and the Audit Committee of HA. Given his professional expertise and the experience working with the HA, Mr Wu's appointment as Chairman will open up new grounds for Hong Kong's health care system.

Dr William Ho said that he and his colleagues would continue to support and work with Mr Wu and is confident that the 50,000-strong workforce of HA will work closely with the HA Board led by the new Chairman and devote dedicated efforts in maintaining and improving public health care services for the community, taking care of the frontline staff who are exposed to a rather harsh working environment, whilst facing challenges in the existing health care system and operations together.

Dr Ho also expressed high appreciation of what the former Chairman, Dr Leong Che-hung has contributed in the past two years in his leading the HA Board and his commitment to a quality health care system.
